



Business Ethics, Reporting, and Governance



Our corporate governance structure promotes ethical business practices

and effective oversight across L&P. The Board is the ultimate decision-making body, consisting of several standing committees with specific oversight responsibilities in areas like financial reporting, enterprise risk management, sustainability, and human resources. The Board approves our Corporate Governance Guidelines, which formalize our commitment to strong governance practices. Jennifer Davis leads our compliance and ethical business practices efforts at the business level.

We maintain good governance through our written policies, annual policy updates and trainings, and regular audits. Each year, employees review and accept our Business Policies Manual, which guides our actions and helps promote the highest levels of responsibility, integrity, and legal compliance. If an employee suspects illegal conduct or a compliance issue, they are encouraged to contact our Ethics Hotline – a telephoneand email-based reporting service that is available 24 hours a day, seven days a week, 365 days a year. To help support good governance and integrity in our work, the Internal Audit team and our external auditors continually review our compliance efforts throughout the company.

With safeguards in place, everyone at L&P is empowered to lead with integrity and can start leading by speaking the truth.

"One thing we can all do every day to promote honesty and integrity is to speak the truth openly and candidly, without fear. This means being transparent in our communications, whether sharing good news or bad," says Jennifer Davis. "By consistently speaking the truth, we build trust and respect with our colleagues, customers, and stakeholders, and we uphold the values of honesty and integrity in our daily actions."

Delivering Results the Right Way: Integrity in Our Finances

In 2002, the United States Congress passed the Sarbanes-Oxley Act (SOX) – a law that regulates how publicly-traded companies like L&P report financial information and conduct audits. As a global company, comprehensive financial reporting across varying locations, geographies, and systems is challenging, but our teams are dedicated to delivering results ethically and accurately.

From the manufacturing floor to our consolidated reporting, our accounting processes use key controls to help create a clear and accurate view of L&P's financial position. These key controls are crucial parts of recording and approving transactions or preventing errors or fraud that could result in a material misstatement in a financial statement. Our Policy and Procedures team ensures controls and procedures address risks and comply with regulatory requirements. This team also regularly works with external auditors and gathers input from the Operations and Corporate Departments to promote continuous improvement.

"We all have the responsibility to ensure our respective areas' books and records are complete and accurate and that we are operating within our established policies and procedures," says Tammy Trent, Chief Accounting Officer. "We rely on everyone to safeguard and preserve the integrity of our financial records and prevent inappropriate behavior. Transparency and open communication are crucial, and we are always looking for ways to improve."

"We help L&P accomplish its objectives by bringing a systematic, disciplined approach to evaluate and improve the effectiveness of governance, risk management, and control processes."

Our internal auditors develop and execute an annual audit plan that conducts financial and operational audits and helps ensure compliance with SOX. They perform a wide range of audits, including location-specific audits, anti-bribery audits, IT audits, and internal control reviews. They also assist with fraud and Ethics Hotline investigations and proactively consult with and survey employees regarding potential ethical concerns. By ensuring an effective and efficient control environment, they ultimately provide assurance that L&P is operating with integrity.

Each internal auditor at L&P is a member of the Institute of Internal Auditors (IIA), committing to upholding principles such as integrity, objectivity, competence, and confidentiality. They follow the IIA's global ethics and professionalism standards and evaluate conformance with these standards through annual internal quality assessments, as well as an external quality assessment every five years. Guided by these ethics and principles, our Internal Audit team takes pride in their work every day.

An actuator is a device that allows a machine or other device to operate by converting energy into mechanical force. The actuator in a Leggett & Platt adjustable bed, for example, adjusts the head and foot of the bed to help an individual find a comfortable position.

Our Automotive business also produces actuators but for use in vehicles. Traditionally, Automotive has produced small actuators that enable functions like opening and closing vehicle windows and operating controls. When the Adjustable Bed and Automotive teams explored opportunities to collaborate, it was discovered that they could team up to create a new, larger actuator designed specifically for adjustable beds.

"This project represents true collaboration and a strategic initiative for the company," says Jay Thompson, President of Adjustable Bed.
